VALUATIONS FOR INSURANCE

Many years of valuation experience have shown us that more than 78 per cent of the clients we visit are underinsured with the consequent risk that any claims for damage or loss is likely be only partially paid. An accurate and up-to-date valuation by an independent specialist provides the comfort of knowing that valuable possessions and household items are correctly insured and that any settlement would accurately reflect loss or damage. A valuation report can also expedite settlement of any a claim.

Full Insurance Valuations

We tailor our valuation to your needs; once we have a full understanding of your requirements, and following agreement, we will place the correct team of specialists into your home.

We provide a confidential and discreet service. Walk Through Validation

An informal yet detailed inspection of your home is made by one of our senior valuers, taking approximately three hours to complete, depending on property size. The appraisal is completed room by room, categorising items correctly and assigning values for replacement purposes. We will provide you/your insurer with a detailed report showing total value by category. Items over £10,000 will be identified and listed separately (max 10 at our set fee) including illustrations. Any areas of concern will be discussed with you. This is a service which is recognised by the insurance industry.

Potential Premium Reduction

Accurate valuation and regular review can reduce your premium as well as give you peace of mind. If you have never had a valuation or validation completed, we would strongly advise this.

An up-to-date valuation may not necessarily result in higher premiums. Fine Art and Antiques are classed as 'low risk' and so have a lower percentage premium. Separating them from 'General Contents' may even attract lower premiums. A full Insurance valuation may also lead to a discount on an existing premium and fulfil all requirements a broker needs to do to comply with the Insurance Act 2016

Should you find yourself under-insured when making a claim, this can have a devastating effect if your insurers apply averages or you are seen as deliberately under-insuring.

PROBATE & TAXATION VALUATIONS

We undertake valuations for all purposes related to the assessment and calculation of taxation and customs duties. With the ever-increasing complexities of taxation, trust and domicile regimes, accurate and up-to-date valuations have become increasingly important.

Inheritance Tax and Probate Valuations

Often referred to by lawyers as a valuation of the Chattels of the deceased. This includes such assets as furniture, paintings, works of art, jewellery, and personal possessions.

The process of probate valuation is to ascertain the total value of the assets held in the estate, so that your solicitor can decide if the estate is liable for Inheritance Tax (IHT).

Where IHT must be paid, however, a realistic and justifiable open market valuation must be ascertained – the value for which they could be sold if a bargain were made between a willing buyer and a willing seller – and in accordance with Section 160 of the Inheritance Tax Act of 1984.

At Doerr Dallas Valuations our team of gualified specialists would attend the property to conduct the appraisal. We charge purely on a time basis, a quotation will be discussed and agreed with you together with our terms and conditions of business.

In fact, all chattels will be accurately assessed which prevents executors accidentally throwing items of value away and ensures that a distribution amongst family members is equitable. We are always happy to value assets/chattels even when there is no legal requirement to do so.

Probate valuations should not be charged as a percentage of the value of the estate, which can inflate the fee unnecessarily.

DIVORCE & FAMILY DIVISION

Divorce and Dissolution of Civil Partnership

The division of chattels on breakdown of marriage or civil partnership often brings particular problems.

Valuation issues can arise in relation to separately acquired property, for example, property acquired by an individual partner before the marriage or through inheritance. Due to market activity, the value of some jointly owned items may have risen out of all proportion to others.

By instructing an independent valuer, the assets owned can be accurately and properly documented and a true market value given. An insurance value is not appropriate on the division of assets.

Valuations are clearly of the utmost importance in these circumstances. A prenuptial agreement can help with the division of a joint estate where too it will be important to include accurate valuations.

Increasingly, a prenuptial agreement and a post nuptial agreement containing accurate valuations can help with a division of an estate. Over the lifetime of the agreement, the valuations benefit from a periodic review.
